Requirements for issuance of permit by the Village of Ceresco to keep, own, harbor or have custody over fowl, chicken, quail, or ducks.

\*Wings must be clipped. No fowl may be permitted to run at large within the corporate limits of the Village.

\*Roosters are not permitted. Keeping or harboring roosters is declared a public nuisance.

\*Fowl are only permitted in residential zoning districts.

\*No more than four (4) fowl, chicken, quail, or ducks on any lot of one (1) acre or less; no more than six (6) permitted on any lot of more than one (1) acre.

\*Weight limit eight (8) pounds.

\*Must have facility and run to be maintained in compliance with all the Village's requirements as condition of the permit.

The requirements are:

1. Limited to rear yard only.
2. Must be kept in good repair, capable of being maintained in clean and sanitary condition, free of vermin, obnoxious smell and substances.
3. Must not constitute a nuisance or disturb neighboring residence due to noise odor or threats to public health.
4. Must be fully enclosed with a roof and shall prevent fowl, chickens from roaming at large and prevent escape.
5. Must not be less than three (3) cubic feet per fowl and the run shall provide not more than five (5) cubic feet per occupant fowl.
6. Must be 30 feet from neighboring dwelling.
7. Must not be closer than five (5) feet from the lot line or the limit set in the Village building and zoning codes to the adjoining property line.

\*Offal, manure, and waste material shall not be permitted to accumulate nor be confined in a manner that is conducting to breeding or attracting of flies mosquitoes, or other obnoxious insects or in any manner that will endanger the public health or safety.

\*Prohibited fowl within the corporate limits of the Village are guinea, geese, peacocks and turkeys.
